A Consortium Model

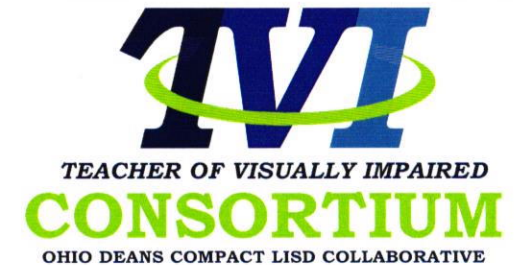
This innovative Post-Baccalaureate Licensure Program is Designed to Increase Education Personnel Prepared to Serve the Needs of Students with Low Incidence Sensory Disabilities.

In response to a personnel need, the TVI Consortium Program offers online access for professional preparation around the state, allowing participants to remain in their perspective areas of Ohio during the program experience, and in return, serve as an IS:VI in Ohio (per the terms of a three-year service agreement required of participants receiving tuition support). Ultimately, the Consortium aims to increase the number of IS:VI teachers as efficiently as possible while facilitating the more equitable distribution of quality personnel resources across Ohio.

Equip yourself to better meet the needs of diverse learners and increase your professional marketability by adding the Intervention Specialist: Visual Impairment license to your credentials through the Ohio TVI Consortium Program.

Participant Eligibility:

Two Pathways to IS:VI Licensure

Pathway 1: For candidates holding an Intervention Specialist (IS) License [Early Childhood, Mild-Moderate, or Moderate-Intensive]

Pathway 2: For candidates holding a Standard (Non-IS) License [Early Childhood, Middle Childhood, Adolescent to Young Adult, Multi-Age]

***Note:** Each individual candidate's prior **coursework** and **experience** will be reviewed in determining course and field requirements specific to his/her preparation pathway. All candidates must meet graduate admission requirements of Lead Institution, Shawnee State University.

Full Tuition Support

Online Coursework
